

CYD MarketNeutral Plus Index

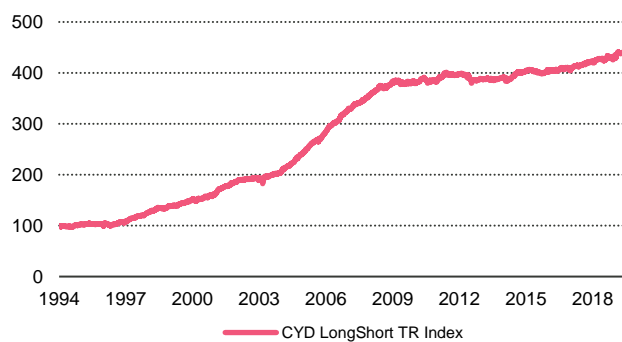
The CYD MarketNeutral Plus TR Index is positioned as a liquidity provider to classical commodity indices which are based on a roll-over strategy in near-to-expire futures positions. To achieve this goal, the index holds two positions: one short position with a near expiration date and one or two long positions with later expiration dates. The index is 2-times leveraged, i.e. for each dollar invested the index holds two dollars in futures positions - divided into long and short positions. The index weighting is derived from the index weights of classical commodity indices.

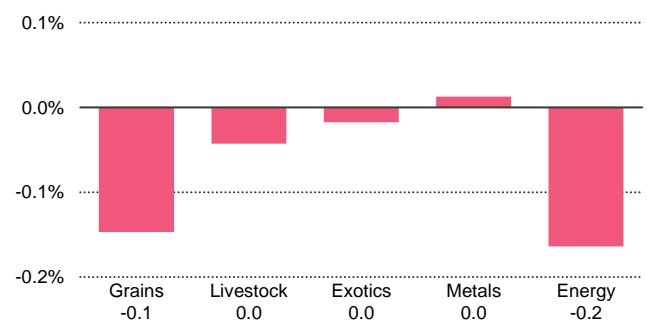

Performance Attribution [%]



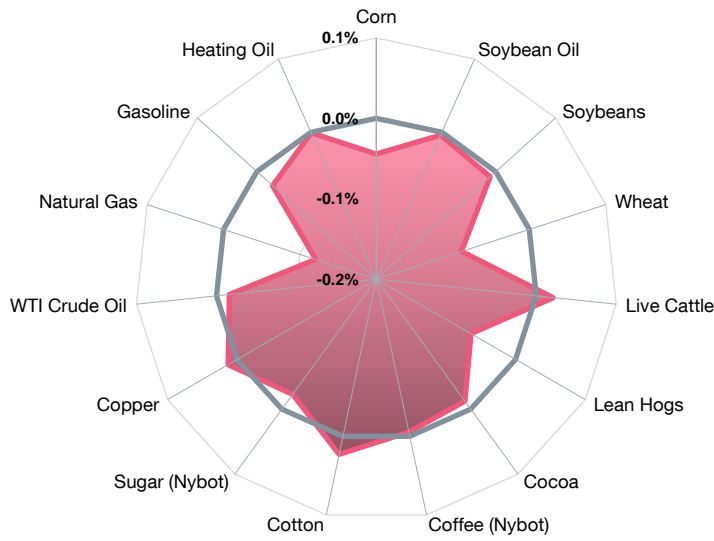
